The policy is titled Prison Rape Elimination Act (PREA) Policy and Procedural Manual. This policy will be referred to throughout this report as the PREA policy. The PREA policy mandates zero-tolerance and outlines the facility's approach to preventing, detecting, and responding to sexual abuse and sexual harassment. The auditor observed that the procedures for following the standards were being met through directive and standard operating procedure.</p> <p data-bbox="229 456 1509 638">The Essex County JDC has a dedicated PREA Committee that includes the Superintendent, the PREA Coordinator, the PREA Compliance Manager, the training officer and a sergeant responsible for training and development, and two social workers who are the crisis support liaisons. The team has the authority to develop, implement and oversee the efforts and has the complete support of the administration. They meet regularly and their processes are very organized.</p>

The PREA policy page 11 requires minimum ratios and other components as required by this standard. The staffing ratios of 1:8 staff to resident ratio during waking hours and a 1:16 staff to resident ratio during sleeping hours is always maintained. There have been no documented incidents of falling below the standards ratio. The population at the time of the audit was 90 residents and the average daily population was 59 residents over the past year. During the tour the auditor witnessed that staffing ratios were complied with, and adequate staff were on post throughout the facility. A thorough assessment of camera coverage is a part of their annual review. The facility is evaluated annually by the Juvenile Justice Commission during the annual review of the Manual of Standards for Juvenile Detention Facilities. The auditor was provided the documented rounds conducted by the PREA Coordinator. A review of the documentation confirm that the unannounced rounds are completed and that they are varied in time and day of the week . The auditor verified compliance of this section of the standard by a review of policy, by reviewing documentation and through interviews.</p>

The agency trains security staff on how to conduct cross-gender pat-down searches, and searches of transgender and intersex residents. The facility does not search or physically examine a transgender or intersex resident for the sole purpose of determining the resident's genital status. If the resident's genital status is unknown, it is determined during conversations with the resident, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. The resident's own views are taken into consideration as to which staff performs a search of a transgender or intersex resident. During interviews staff physically displayed how to conduct a cross-gender pat search using the blade of the hand. During resident interviews youth stated that staff of the same gender always search them.</p> <p data-bbox="229 546 1509 873">The Essex County JDC has policies and procedures that enable residents to shower, perform bodily functions and change clothing without nonmedical staff of the opposite gender viewing them in a state of undress except in exigent circumstances or when such viewing is incidental to routine cell checks. The shower facilities are individual and private and therefore allow for residents to shower and change clothing without staff viewing them in a state of undress. Rooms within the housing area have toilets. Staff and youth stated that staff announce their presence when entering a housing area of the opposing gender as the staff. Female youth indicated that male staff typically don't come into their unit. A Captain or Sergeant may come in, but never during shower times and they check with the pod officer before entering and announce when they come in. The auditor noted the announcement was made during the tour of the facility. Both staff and youth stated cross-gender viewing is not an issue and youth have privacy.</p>

All staff are instructed in the procedures for assisting youth who may need additional assistance. The number and instructions for this service are posted prominently throughout the facility. The facility does not use residents to interpret for other residents. Most staff acknowledged these procedures during the interviews, but the auditor felt that although compliant, the use of the Language Line could be strengthened. All staff should know where to find the number to access the Language Line. Staff work with youth who have either visual impairments or reading and comprehension issues by verbally reviewing the material. The agency takes appropriate steps to ensure residents with disabilities (for example, residents who are deaf or hard of hearing, those who are blind or have low vision, or those who have intellectual, psychiatric, or speech disabilities), have an equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. The policy states the facility does not rely on resident interpreters, resident readers, or other types of resident assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the resident's safety. The intake PREA information and the PREA posters are provided in Spanish format.</p>

The facility has performed background checks at the time of employment of new hires and maintained checks every five years. Essex County JDC performs Child Abuse and Neglect Registry checks at the time of employment. They have a form asking the questions regarding sexual misconduct and a continuing duty to report that is completed upon hiring. However, these were not completed during the annual review process. The continuing duty to report is also outlined in policy and all staff are required to sign that they have read and understood the policy. The facility conducts the required checks with former institutional employees regarding sexual misconduct while employed.</p> <p data-bbox="229 479 1509 772">CORRECTIVE ACTION: The auditor was provided several samples that these questions were asked of employees during the hiring process, but not during the annual review process. To comply with section (f) of this standard the auditor required the ECJDC provide the auditor verification that they have again asked directly during the annual reviews of current employees about previous sexual misconduct and the employees continuing affirmative duty to disclose any such misconduct. On April 7, 2022, the PREA Compliance Manager provided the questionnaire for one employee and another one was provided on April 6, 2022. The auditor provided a random sample of staff names to be provided to ensure that this was being completed for all staff. These were provided to the auditor on June 16, 2022. The ECJDC has added this to their employee evaluation process to ensure it is completed annually.</p>

Video is retained for 90 days and enhances investigation efforts.</p>

The Special Victims Unit Sexual Assault Response team includes a SANE nurse and an advocate from the prosecutor's office. The investigator, the advocate and the SANE nurse work cooperatively together to ensure all evidence is properly collected, a forensic medical examination is conducted if requested by the victim, and the victim is supported by a qualified advocate. The staff take into account the needs of the victim and take direction from the prosecutor's office on when to transport sexual assault victims for a forensic examination by a Sexual Assault Nurse Examiner (SANE). Dependent on the age of the victim there are other resources available at University Hospital Rutgers in Newark. The Essex County Prosecutor's Office through a SART team uses a coordinated response which is orchestrated by the SART Coordinator. This training covers the Essex County JDC's zero tolerance policy regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment. Once the resident is transferred to the Orientation Unit, previously they were shown a video on more comprehensive PREA information. However, since the onset of COVID they no longer hold large groups for newly arrived residents. PREA training sessions are now done individually by the training officer with each youth in the Orientation Unit. The posters are both in English and Spanish.</p> <p data-bbox="229 837 1509 1030">CORRECTIVE ACTION: The auditor required documentation of the second training session to support that the resident education is given in two parts – the first being very basic information given within the first 72 hours while the youth is still in intake or separate from the general population of the facility and then the more comprehensive information while the resident is in the Orientation unit, but before 10 days. The auditor provided the ECJDC a random sample of resident's names to provide documentation of the more comprehensive training. This was provided to the auditor on June 16, 2022.</p>

	<p data-bbox="244 210 453 237">Auditor Discussion</p> <p data-bbox="244 271 1490 501">Through interviews with the nurse and the social worker it is apparent they are knowledgeable in how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to victims of sexual abuse and sexual harassment; and how and to whom to report allegations or suspicions of sexual abuse and sexual harassment. Nurses and social workers receive the same training as all detention staff. However, the nurse is a contractor. Her training is provided by her agency. The auditor recommended she complete the NIC training for medical providers. The Social Workers have completed this specialized training. The staff verbally disclose to youth the limitations of confidentiality and their duty to report at the initiation of services.</p>

In reviewing the screening form the auditor believes that it is not objective. She explained that soon after the on-site portion of the audit they changed their procedure so that the PREA Coordinator, the PREA Compliance Manager and the Training Officer share the duty of screening youth during intake while the resident is in ARO. They created a new screening form that totals points for certain answers that will more objectively screen for the potential for victimization or the potential to perpetrate sexual victimization. On April 7, 2022, May 11, 2022, and June 16, 2022, the PREA Compliance Manager provided samples of updated, objective PREA screenings.</p>

The facility considers the concerns of a transgender or intersex resident's own view with respect to his or her own safety. Those views are given serious consideration, and this was demonstrated through the interviews of staff. All youth shower separately at the facility. The facility does not place lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed, or other assignments solely on the basis of such identification or status, nor does the facility consider lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive. The facility indicates through interviews that they will consider on a case-by-case basis assignment to a living unit that will ensure the resident's health and safety, and whether the placement would present management or security problems. Facility procedure is to manage a resident's room placement rather than using isolation as a means for protecting the resident's safety.</p>

They can report to staff including medical and the social worker, the facility advocate or write a grievance. They also can speak with the Administrator or any staff. They have regular contact with their family. They can call externally to the NJ Abuse Hotline provided by the New Jersey Division of Child Protection and Permanency (DCP&P). The number to access NJ Abuse is available on posters posted in the dayroom near the telephone. The handbook informs youth that they may call the DCP&P hotline at any time. The auditor spoke with a DCP&P staff worker on the NJ Abuse hotline who walked through the process if a youth calls to report abuse. Youth are always able to request staff to place a call to the hotline on their behalf. They can speak with the nurse or social worker privately at any time by simply making the request. The staff accepts reports made verbally, in writing, anonymously, and from third parties and promptly documents any verbal reports. See the corrective action under Standard 115.353. On June 16, 2022, the PREA Compliance Manager provided corrected posters and handbook that lists reporting methods and victim support services under two distinct headings.</p>

There is no time limit on when a youth can submit a grievance regarding an allegation of sexual abuse. The grievance method is also outlined in the youth handbook and the youth advocate goes over this process with each youth while they are in the Orientation Unit. The auditor reviewed policy, procedures, and grievances (none related to sexual abuse/sexual harassment). Youth may have assistance in completing a grievance from another juvenile, a staff member, or third party. Staff and youth interviews confirmed their knowledge of how the grievance process can be used to report sexual abuse and sexual harassment.</p>

The ECJDC provides youth with reasonable and confidential access to their attorneys and parents. In addition, all youth interviewed reported that they had contact with their families regularly. If the youth is involved with the Division of Child Protection and Permanency (DCP&P), they may already be assigned a case worker who assists them in accessing services through Care Management Organizations (CMO's) that provide a range of treatment and support services to children.
