The intent of the nine-member Task Force is to provide "transparency and accountability" for ECCF operations, to protect the "lives, health, safety, and rights of all people confined at the ECCF," and to ensure that the "conditions of their confinement are safe, sanitary, respectful, and humane," as outlined in the County ordinance. The Task Force operates independently of the County government and has the authority to inspect ECCF, interview correctional officers, inmates, and detainees, and review systemic issues and concerns.

Members of the Task Force were nominated by Essex County Executive **Joseph N. DiVincenzo**, **Jr.** and appointed by the **Board of County Commissioners** in June 2020 through an established advice and consent process.
